1. I agree for myself, my heirs and my personal representatives, to hold harmless, and forever release and discharge Pace and all its officers, agents and employees from and against any and all claims, demands, actions or causes of action, on account of damage to personal property, personal injury, or death which may result from my use of the Fitness Center's equipment and facilities and my participation in Fitness Center Programs and activities and incident thereto.

6. This release shall be construed in accordance with, and governed by, the laws of the State of New York. Any litigation relating to this Release or the Event shall be conducted in a court of competent jurisdiction in the State of New York, County of New York.

Membership Levels

Community - \$880 annual fee, plus \$150 one-time initiation fee. Spouse/ domestic partner memberships are a \$715 annual fee, plus the one time initiation fee. Children memberships are \$130, plus the one time initiation fee. (16-21 only)
Alumni - \$350 annual fee, plus \$125 one-time initiation fee. Spouse/ domestic partner memberships are a \$320 annual fee, plus the one time initiation fee. Children of Alumni membership fee is \$130 plus the one-time initiation fee. (16-21)
Pace Faculty/Staff (full-time and part-time)-\$260 annual fee. There is no initiation fee for faculty and staff members. Fee for spouse is \$285 and the fee for children is \$105. (16-21 only)
Police/Fire/Ambulance - \$440 annual fee, plus \$125 one-time initiation fee. Spouse/domestic partner memberships are a \$715 annual fee, plus the one time initiation fee. Children memberships are \$130, plus the one time initiation fee. (Ages 16-21 only)
Restricted Memberships - Restricted memberships at each membership level are available for 20% off the regular cost of the membership. As a restricted member you have access to the facility at all times except for 2pm-9pm Monday-Friday when school is in session.
Senior Citizen Discount - Anyone 63 years of age or older is eligible for a 20% discount.

Annual memberships (September 1 - August 31) are open to all Pace students, faculty, staff, alumni, and local Westchester residents. All spouses and children of faculty/staff and alumni are only eligible for the reduced rate if the actual faculty/staff or alumni is a member. Children must be of ages 16-21. A limited number of guest passes are available daily for a cost of \$10 per visit. Fitness classes are also available for no fee. Members are notified in advance when the arena is closed due to a University event. Athletics schedules are available at the front desk. Memberships are to entire facility. There are no exclusive pool memberships available.
