

2021 Faculty Scholarship and Research Award Covid-19 Collaborative Interdisciplinary Research Award Grant Proposal Guidelines

**Description:** This funding opportunity supports faculty who collaborate across disciplines to create research proposals related to COVID-19.

The societal impact of COVID-19 and the Coronavirus that causes this disease was sudden and profound. From public health, to the economy, to how we use technology and the future of work, our lives will be forever changed. But in what ways and how can we contribute to the discussion about what comes next?

We are seeking to integrate faculty expertise across disciplines and from each of the six schools at Pace University. The goal of this grant program is to seed new research in an interdisciplinary manner. The program requires the research be collaborative to maximize novel and creative thinking about every aspect of the COVID-19 pandemic. We envision this program to be a forum for studying societal responses to the current crisis, recovery, resilience, and the reimagining of our lives and work.

Three to four grants of up to **\$5,000** (placed in a Scholarly Research Account) will be awarded. Applications are encouraged from full-time faculty in any discipline and across all schools. Funds can be used for research supplies, course release (upon college approval) or summer salary.

# Eligibility:

- Only full-time clinical, tenure-track or tenured faculty are eligible to apply
- A faculty member may submit only *one* proposal to this program
- Faculty are invited to apply to any of the different opportunities but can only expect to receive one award

The deadline for proposal submission is Friday, February 26, 2021 at 5pm.

Please prepare your application in Word, compile all the required documents, and convert all the files into a <u>single PDF</u>. Applications should be submitted through our <u>online</u> <u>submission system</u>.

# I. Proposal Format:

Each proposal must be a maximum of 6 pages (single spaced, 12 pt. font, one-inch margins).

# B. Title Page and Summary (one page)

Project title, Instructor names and schools/departments, and a 200-word abstract

# C. Project Description (3 pages)

- 1) Describe the research question and the specific aims of the study
- 2) Describe the methods for your research
- 3) Describe how you will assess the outcomes of the research plan
- **4)** Describe the role of each investigator in this collaborative effect and how the collaboration itself leads to novel and creative approaches.

# D. Budget (one page)

Use the template provided to briefly describe your <u>budget and justify</u> the expenses requested. You can request course released time (with approval), summer salary, materials/supplies or graduate assistant stipends etc.

# E. Additional Required Information (not included in 6-page limit)

- (i) <u>Citations</u> can be added on a separate page(s)
- (ii) <u>Current and Pending funding</u> (if none, then state 'none' see template)

(iii) Append a <u>biosketch for each collaborator</u> using the template provided in the proposal form (or use an existing NIH or NSF biosketch if available).

# 2. Proposal Submission

Proposals must be submitted via our <u>online submission system</u> as a **single PDF** and contain the following:

- 1. Signature Page with the names of the PI, Department Chair, and Dean
- 2. Title Page and Summary
- 3. Project Description
- 4. Budget and budget justification
- 5. Additional Required information (citations, biosketch and current and pending grants)

#### 3. Proposal Review and Evaluation Criteria

# A faculty committee will review each proposal and consider the following criteria:

- 1) Novelty of the research idea and feasibility of the research plan
- 2) The collaborative nature of the proposal and how each discipline contributes to the overall plan
