# Statement of Domestic Partnership

## DOMESTIC PARTNERSHIP REGISTRATION DOCUMENTS

The following are examples of acceptable documents that serve to register a Domestic Partnership. Employees must provide *different* documentation for each of the two categories below. Other suitable documents may also be presented for review.

### Common Residence (Showing at least 2 years of Common Address with the Domestic Partner)

- Joint lease or mortgage from 2 years in the past and from the present
- Unexpired driver or non-driver photo I.D. showing 2 years at a common residence
- Utility bill (telephone, cable TV, gas/electricity) from 2 years in the past and from the present
- Bank account/credit card statement from 2 years in the past and from the present
- Previous 2 years of state resident income tax filings
- State jury duty attendance certificate from 2 years in the past showing common address
- Voter registration from 2 years in the past showing common address

### Financial Interdependence (Showing at least 2 years of Financial Interdependence with the Domestic Partner)

- Joint lease or mortgage from 2 years in the past and from the present
- Joint checking, savings or brokerage account from 2 years in the past and from the present
- Joint automobile registration from 2 years in the past and from the present
- Joint ownership of a tangible major asset from 2 years in the past and from the present
- Designation of domestic partner as beneficiary in a will from 2 years in the past and from the present
- Designation of domestic partner as beneficiary for life insurance or pension retirement benefits from 2 years in the past and from the present
- Unexpired durable power of attorney from 2 years in the past

### NOTE:

Employees are encouraged to consult a legal advisor to determine debt obligations and credit and collection implications, if any. Employees are also encouraged to consult a tax advisor to determine tax consequences and liabilities, if any.
