Billing Due Dates & Late Fees

Standard Billing Due Dates

- Fall 2022: August 1, 2022
- Spring 2023: January 5, 2023

*You will be subject to a \$200 late fee if you have not made payment by the billing due date

Billing & Payment

Pay your bill online at www.pace.edu/pay.

- **What are the acceptable methods of payment?**

- Check, Money Order, Wire Transfer, Fly Wire, Credit/Debit Card

- **Can payments be made over the phone?**

- No. Payments can only be made online (credit/debit card or electronic check), in-person or via mail (check or money order)

Health Insurance

- **Student must submit a health insurance waiver each new ACADEMIC year.**
- Health Insurance Waivers can be completed online via the MyPace Portal.
 - Log onto My Pace Portal
 - Select the Student Tab
 - Select “Health Insurance Waiver” link located in the Express links box.
 - *Please allow 24 hours from submission for your account to update.
 - Select “Health Insurance Waiver-International” if you are an international student
 - *Please allow the insurance carrier up to 30 days to review your waiver and inform you if the waiver was approved or denied.

NYS Aid & Outside Scholarships

- For New York State residents seeking New York State Aid, students must apply through New York State Higher Education Services Corporation (HESC) website: www.hesc.ny.gov.
- If a student intends to receive an outside scholarship, they should ensure that they provide a letter informing the Student Accounts Office of the anticipated scholarship amount
- All outside scholarship payments should be mailed to the Payment Processing Center

Immunization Compliance

Students must be compliant with MMR, meningitis and COVID 19 requirements to access campus for the Fall 2022 term.

Immunization Compliance

New York State Public Health Law requires that all college and university students enrolled for at least six (6) semester hours or the equivalent per semester, or at least four (4) semester hours per quarter, submit proof/documentation of immunization.

MMR

- Measles: Two (2) doses given after your first birthday and at least 28 days apart (the first dose is considered Day 0)
- Mumps: 1 dose after first birthday
- Rubella: 1 dose after first birthday
- Or, show proof of immunity to measles, mumps and rubella by taking a blood antibody titer test.

Meningitis

- Students must also document that they either have received the meningitis vaccine or have declined to receive it.

Immunization Compliance

COVID-19 Vaccination:

For the Fall 2022 semester, Pace University will require all students who will be on campus (e.g., residential, commuter, and online students who plan to use University facilities) to receive, and to provide proof of having received, a COVID-19 vaccine and COVID-19 Booster, if eligible, approved for use emergency use by the the US Food and Drug Administration or the World Health Organization. Students who fail to provide such documentation are not permitted to physically access Pace campuses.

Immunization Compliance

- All students must submit all proof/documentation of their immunization records through Medicat Compliance Services.
- You may submit your immunization documents online at: www.pace.edu/patientportal
- Deadline:
Fall 2022 Deadline: August 1, 2022
- Please allow 7 business days for immunization document submission to be reviewed and your account updated. Students will be notified by email when documents have been reviewed.
