INTERVIEW WITH ADJUNCT PROFESSOR RIC SWIERAT



Tell us about your journey that led you to work in the Notfor-Profit sector

My educational background is as a special education teacher and school administrator. Early in my teaching career, I worked in a number of public school districts creating innovative "resource room programs" to support students with a variety of disabilities who were mainstreamed in typical classrooms. This led to an interest and opportunities to have greater responsibilities in supervising teachers and clinicians in programs supporting children and adults with developmental disabilities. I left the public school system and joined the not-for-profit sector to do this.

I supervised a number of programs funded through NYS Education funding and Medicaid which led to becoming an Executive Director, first in a small NFP and later at Westchester Arc. During this time (1970 through 2018) I was fortunate to be involved with the growth of the field of developmental disabilities for children and adults in New York State. This was also during the time that the New York State institutions for people with disabilities closed down and returned the patients to community programs and residences.

You had a long career as the Executive Director at the Arc of Westchester. What are some lessons you learned for effective leadership throughout your career?

These times were confusing, challenging, and exciting. The values and skills that served me best during this time included always understanding that I needed to be a continuing student....learning new skills every day. I believe in using educational principles in working with staff and boards so that we all approach the challenges with common understandings and information.

So, listening to the families and individuals we serve, the board, and the staff provided me with clear directions to be most effective in using the available resources and skills to build effective programs. I also taught clear information and facts to our board and staff so that we could use the resources and skills to be effective in our work. This means listening to others, translating what I am hearing into needs and objectives, aligning with the resources available through government, and understanding that at times we need to turn to private resources to fully meet the expectations of our constituencies.

INTERVIEW WITH RIC SWIERAT CONT.

How do you see the Not-for-Profit sector evolving? Are there specific opportunities or challenges you believe are present amid the Covid-19 pandemic?

The COVID pandemic has provided the nonprofit sector the opportunity to shine and advance its talents and services. The pandemic exposed the vulnerability of many people and our communities economically, socially, in mental health, housing, food, information, etc... The nonprofit sector had to continue to provide services, and often expand services, despite challenges in resources, technology, and staffing. We have seen significant innovations in program delivery during this time.

The use of technology, in particular, was missing in the nonprofit sector prior to the pandemic. However, the nonprofit sector quickly responded by adopting technology to support the work of the organizations.

There is still a significant lack of staff and a need to address the poor pay levels in the nonprofit sector. However, the pandemic has clearly placed this issue at the forefront of our state and federal representatives. We will see legislation and funding to address these issues the next few years.

What qualities do you believe are most relevant for public administrators?

Listen first before responding to an issue.....often the initial problem issue is not clear and we need to explore further before creating solutions.

Treat your work with boards, staff, volunteers, and the community as a teacher. The issues that face us are complicated. We need to learn, explore and examine these issues as a classroom activity. The best way to find common solutions is to approach them with common knowledge and understanding.

Management and administration is a team sport that requires respect and appreciation for using all our skills in a cooperative manner.

Try to learn more about those things you do not understand. I spent a great deal of time studying the funding systems in a detailed manner so that when a budget was presented, I could confirm that the funding was properly used.

Seek ethical people around you and opportunities to have outside confirmation of the quality of your work

INTERVIEW WITH ALUMNUS GREGORY RIVERA



Tell us about your journey that led you to a full-time position at the Village of Rye Brook.

I have Heather Novak to thank the most for pushing and inspiring me to pursue an MPA. I had originally planned on only doing a BA in Political Science and then seeking employment postgraduation. Eventually, I gave in and enrolled in the 5-year BA/MPA program. At times, I found the program challenging, especially when working on my Capstone.

Thankfully, Dr. Scutelnicu talked me out of giving up t and convinced me to see the program through. She selected me as one of two students to work on the Village of Port Chester police reform study mandated by former Governor Cuomo in the wake of George Floyd's death. I helped to analyze the qualitative openended portion of the study, which focused on what Port Chester residents viewed as the greatest issues/needs facing the Port Chester Police Department. Through this experience, I had my first interaction with the Village of Port Chester leading to an internship with their Village Manager, Stuart Rabin. His mentorship was instrumental in helping me land my current position with the Village of Rye Brook.

What are your day-to-day responsibilities?

One of the best aspects of my position is the opportunity to learn new things every day. Each day is different, and that makes the job exciting. Some of my day-to-day responsibilities include, but are not limited to helping prepare the bi-monthly Village Board of Trustees agenda, acting as the Safety Coordinator for the Village, serving as the Staff Liaison to the Village of Rye Brook Sustainability Committee, and handling insurance-related matters. Above all, I aim to help the Village of Rye Brook residents to the best of my ability, including helping them with constituentrelated inquiries. I may not always be able to provide a resident with the results they seek, but I do my very best to explore all avenues to achieve the most desired outcome.

INTERVIEW WITH GREGORY RIVERA CONT.

What aspects of the Pace MPA program prepared you for your career?

The entire program helped me in some way, shape, or form to prepare me for where I am now. As part of my internship, I worked on the police reform study with the Village of Port Chester and learned how to analyze survey data. Acquiring data analysis skills came in handy when working on my Capstone, taught me how to collaborate with local government, and introduce me to the Village of Port Chester. The study was presented to both the Village of Port Chester Board of Trustees and the appointed Police Reform Board.

Though I have prior internship experience with elected officials and political campaigns, the post-graduation Village of Port Chester internship provided my first experience of government civil service, which I knew much less about.

Lastly, my Capstone project journey with Dr. Scutelnicu as my advisor was a fulfilling experience. We collaborated with the Westchester Children's Association (WCA), a non-profit based out of White Plains that deals with youth issues such as housing insecurity, poverty, criminal justice, etc. WCA conducted a survey about remote learning in May 2020 that was distributed to parents and guardians throughout Westchester. We extracted data points from the survey that allowed us to determine what demographic groups struggled with or coped with remote learning the best. It was a challenging, yet rewarding experience in which I analyzed and interpreted survey data and allowed me to practice presenting research findings to important stakeholders.

I have had the privilege to present both studies I worked on at different conferences, giving me the opportunity to practice public speaking with different audiences.

What advice would you give to current MPA students?

Many factors have helped me to get where I am today. I strongly encourage current and future MPA students to network extensively, not limited to internships and work connections.

It is critical to develop relationships with fellow MPA students and share life experiences with each other. Some students were traditional college-aged students like myself. Other students currently working in their perspective fields were able to share more in-depth professional experience, which helped make class lessons more applicable to real-life scenarios. I advise students to get to know the professors well.

While at Pace, including as an undergrad, several of my professors mentored me. I believe students should get to know the faculty as individuals, not just as teachers. I also think it's very important for students to not fear adjusting original academic plans. I speak from experience because I did not originally plan on pursuing an MPA. I also had planned on taking the exam rather than working on a Capstone project.

It's okay if you have uncertainty about your potential career path, what matters is a willingness to keep trying and putting in your best effort. Students should take stock of their strengths and weaknesses so they can build on the strengths and improve their weaknesses. I can't stress enough that excelling at everything is virtually impossible, but it should not stop one from trying.

It is critical to avoid comparing yourself to others, especially those with more experience because everyone has their own strengths and weaknesses, and everybody learns at a different pace. I think it is important to learn to work well with others and I speak from experience, things go more smoothly and effectively when everyone works as a team.

My final message would be to have the utmost humility in whatever career path you choose. Even if you are knowledgeable in your field, I guarantee there is always a learning curve. I consider myself knowledgeable about government, but in my new role as Assistant to the Village of Rye Brook Administrator, I have come to realize, that the more I learn the more I'm still new at this.

Summer 2022 Class Offerings

PAA 632: POLICY STUDIES

This course will examine the theories and concepts used in the study of public policy. It describes the development and use of models for policy formulation, analysis and evaluation. Policies of special, professional interest to the student are examined in detail with emphasis on the development of analytic skills. Faculty guidance is provided in the assignment of special readings as the student develops policy research papers. Required of all students in the government track.

PAA 614: STRATEGIC PLANNING & MARKETING

This course examines basic concepts in strategic planning and marketing with special emphasis on the organization and management of the strategic planning process, marketing decision models, and techniques for the promotion of services to the public. Discussion of the ethical issues surrounding marketing is included. Required of all students with a specialization in planning and evaluation or nonprofit financial management.

PAA 605: ETHICS AND LEADERSHIP

This course is designed to make students aware of their responsibility as professionals in leadership and administrative positions in our complex society. Individual values and normative choices associated with the implementation of public policy will be discussed. Social, legal, and economic realities will be examined in light of philosophical arguments. Case studies and current examples relevant to government, health care, and nonprofit organizations will be used as practical applications of ethical precepts and conduct.

PAA 651: COMMUNITY HEALTH Assessment

Concepts relevant to understanding patterns of health and illness in the community are explored. Factors which influence the use of health services are discussed. Materials are drawn from various disciplines including epidemiology, vital statistics, demography, sociology, psychology and anthropology. Required of all students in the health administration track.

PAA 670: THE NOT-FOR-PROFIT SECTOR

This course examines the history of nonprofit organizations in the United States to develop a social perspective and a sense of the magnitude, scope and functions of the nonprofit sector. The course also looks at the relationship of the nonprofit sector to government and business. The course explores the theoretical basis on which social scientists have sought to understand the nonprofit sector in our economic, political and social environment. Issues shaping the future role of the nonprofit sector will be discussed. Required of all students in the nonprofit management track.

PAA 616: PROJECT DEVELOPMENT AND GRANT WRITING

This course explores the historical and conceptual background of private foundation grants in the United States. The student will learn to identify appropriate sources of funding and to write grant proposals. Intersections of the grant writing process with the project development, program and strategic planning, and external partnerships and collaborative enterprises will be stressed. Emphasis will be placed on grants measurement in the government, health care and nonprofit sectors.

WHEN COVID 19 HIT THE US - WE TRULY HAD NO IDEA WHAT WE WERE DEALING WITH. SEVERAL MONTHS IN, ITS IMPACT HAS TRULY CHALLENGED EVERY PROFESSIONAL ADMINISTRATOR TO TACKLE ISSUES THEY HAVE NEVER DEALT WITH BEFORE. IT HAS FOSTERED NETWORKS AND CONVERSATIONS THAT SHOULD HAVE HAPPENED BEFORE, BUT HADN'T.

AND IT HAS CREATED A WHOLE SET OF NEW ELEMENTS TO OUR INDUSTRY'S LANGUAGE AND CONVERSATION - THINGS LIKE - SUPPLY CHAIN SHORTAGES, SOCIAL DISTANCING, CONTACT TRACING, AND WORDS LIKE "VAXED" AND "BOOSTED". EVEN HOW WE CONDUCT OUR PUBLIC MEETINGS HAS CHANGED - THE WORLD HAS COME TO KNOW HOW TO TALK TO EACH OTHER ON ALL FORMS OF TECHNOLOGY - WEBEX, ZOOM, AND TEAMS.

BUT ADMINISTRATORS ALL OVER HAVE RISEN TO TAKE ON THIS CHALLENGE. SOME OF THE VERY REAL EXAMPLES OF COVID-RELATED ISSUES WE'VE DEALT WITH IN WESTCHESTER COUNTY INCLUDE: -PURCHASING AND DISTRIBUTING HUNDREDS OF THOUSANDS OF PIECES OF PERSONAL PROTECTIVE EQUIPMENT TO HELP OUR EMPLOYEES AND WORKERS ON THE FRONT LINES TO STAY AS SAFE AS POSSIBLE;

-THINNING OUT OUR HOMELESS SHELTERS AND PRISON POPULATIONS TO REDUCE THE POSSIBILITY OF THE VIRUS SPREADING IN THESE FACILITIES;

-DEFINING "ESSENTIAL SERVICES" AT MANY LEVELS - FROM OUR OWN EMPLOYEES, TO BUSINESSES THAT ABSOLUTELY NEEDED TO CONTINUE TO OPERATE DURING THE EARLY STAGES OF THE PANDEMIC;

-DEALING WITH THE ISSUES OF GETTING FOOD TO PEOPLE WHO NEEDED IT: OFROM THE SENIOR CITIZENS WHO COULD NO LONGER GET TO THEIR SENIOR NUTRITION PROGRAMS;

OTO THOSE THAT HAD BEEN INFECTED AND WERE FORCED TO ISOLATE;

OTO THE THOUSANDS OF LOWER INCOME WORKERS WHO HAD BEEN LIVING ON THE EDGE AND FOR A TIME WERE TOLD THEY COULDN'T GO TO WORK AND HAD NEVER ASKED FOR FOOD SERVICES BEFORE;

OTO THE SCHOOL CHILDREN WHOSE SCHOOL LUNCH AND AFTER-SCHOOL PROGRAMS WERE FORCED TO CLOSE;

-WE HAD TO REDEFINE VERY QUICKLY HOW WE COULD WORK AND MEET REMOTELY AND GET ENOUGH EQUIPMENT IN PLACE TO ALLOW THIS TO HAPPEN;

-WE RECOGNIZED THE NEED FOR AND PUT IN PLACE MENTAL HEALTH SERVICES FOR A WHOLE NEW POPULATION THAT NEEDED THIS HELP FROM DEALING WITH ISOLATION OR THE LOSS OF A LOVED ONE;

-WE HAD TO WALK THE FINE LINE BETWEEN PREVENTING EVICTIONS AND RECOGNIZING THE NEEDS OF THE LANDLORDS WHO HAD MORTGAGES TO PAY;

-WE PUT IN PLACE 24-HOUR DAY CARE FOR ESSENTIAL WORKERS;

-WE HAD TO HELP KEEP THE MAIN STREET BUSINESSES - IN BUSINESS;

-WE HAD TO DEAL WITH THE SHEER QUANTITY OF THE DECEASED AND THOSE STORAGE NEEDS;

-AND ONE WOULD HAVE THOUGHT THAT SETTING UP ACCESSIBLE AND SAFE VACCINATION SITES AND GETTING ENOUGH VACCINES TO MEET THE NEEDS AND EXPECTATIONS WOULD HAVE BEEN ENOUGH OF A CHALLENGE, BUT THEN WE HAD TO MEET THE CHALLENGE OF ENCOURAGING ALL SORTS OF POPULATIONS TO ACTUALLY GET VACCINATED.

IMAGINE DEALING WITH ALL THESE CHALLENGES WITHOUT HAVING THE ABILITY TO READ THE END OF THE BOOK AND SEE HOW AND WHEN THIS WILL END - THIS IS THE EVERYDAY WORLD OF A PUBLIC ADMINISTRATOR!

BUT THE BEST ADMINISTRATORS USE THESE CHALLENGES TO CREATE REAL CHANGE. FOR EXAMPLE -SCHOOL DISTRICTS AND MUNICIPALITIES ARE NOW TALKING REGIONALLY AND TO EACH OTHER LIKE THEY NEVER HAVE BEFORE;

OUSING TECHNOLOGY LIKE ZOOM AND WEBEX HAS ALLOWED MANY MORE PEOPLE TO PARTICIPATE IN THE PUBLIC MEETINGS;

OSTAFF WITHIN COUNTY GOVERNMENT STEPPED UP AND USED THEIR VOLUNTEER CONNECTIONS TO HELP US BETTER UNDERSTAND THE WORKINGS OF OUR NONPROFITS AND HOW BEST WE COULD HELP THEM TO GROW AND SCALE THEIR OPERATIONS TO MEET THE MUCH GREATER NEEDS CAUSED BY THE PANDEMIC;

OWE HAVE BETTER COMMUNICATION WITH THE COURTS ON EVICTION PROCEEDINGS AND TENANTS HAVE MUCH BETTER ACCESS TO LEGAL ASSISTANCE TO STATE THEIR CASE;

OISSUES LIKE EQUITY, SOCIAL JUSTICE AND AFFORDABILITY ARE BEING INCORPORATED INTO MOST EVERY TOPIC AND POLICY THAT WE ARE WORKING ON;

THESE ARE JUST A FEW EXAMPLES. BUT AS WE ALL KNOW, WE'RE NOT YET DONE WITH COVID, SO I'M SURE THERE ARE EVEN MORE LESSONS WE WILL LEARN BEFORE WE'RE DONE.

AND NOW, AS YOU FINISH UP YOUR STUDIES AND JOIN US IN THIS PUBLIC ADMINISTRATION WORLD, YOU WILL BRING A WHOLE NEW VISION AND BACKGROUND TO THE ISSUES THAT WE DEAL WITH. I CAN TELL YOU FROM EXPERIENCE THAT YOUR INVESTMENT IN YOUR PACE MPA WAS WORTH IT! WELCOME TO OUR WORLD!

I LEAVE YOU WITH TWO QUOTES - ONE FROM FORMER US SECRETARY OF STATE CONDOLEEZZA RICE AND THE SECOND, WHICH I ACTUALLY HAVE ON A PLAQUE IN MY OFFICE, FROM GANDHI -FIRST - "THERE'S NO GREATER CHALLENGE AND NO GREATER HONOR THAN TO BE IN PUBLIC SERVICE."
