# **One Pace Plaza East Renovation**

- The project team received the 50% Construction Document Submission on February 2<sup>nd</sup> and has scheduled page turns and reviews with ITS, Ed Media, Security, Dining & Auxiliary Services, Mail, Special Events, Facilities, Sands College, Creative Arts, & Media, and Maker Space user groups.
- The project team will present to the NYC SGA on Tuesday, February 27<sup>th</sup>.
- The Design team is reviewing the updated equipment list for the Maker Spaces, a follow-up meeting to review this list and the latest layout is being scheduled in the upcoming weeks.
- Demolition is underway, preparation and protection setup for abatement within the project site. Abatement is anticipated to start upon DEP approval. Pace's logistics team met with the construction team to review planned work ahead and communicate required advanced notices.

#### 15 <u>Beekman</u>

- The terrace railing replacement project is ongoing on the 25<sup>th</sup> floor. Outdoor construction on the 25<sup>th</sup> floor Terrace is well underway and is expected to be completed by Mid-March.
- The 6<sup>th</sup> floor terrace project will extend beyond the end of April, due to complications with fire department approval. The glass railing height will be 48", still waiting for FDNY official approval. The scaffolding will be in place until work is completed for safety measures.
