EARLY DECISION AT PACE UNIVERSITY

If Pace University is your top choice, you have the opportunity to apply through the Early Decision program and receive both an admission decision as well as a scholarship and financial aid package earlier in the admissions cycle.

Please be aware that Early Decision admission is binding—if you are accepted under this program, you must enroll at Pace and withdraw any applications for admission to other institutions.

IF YOU ARE ACCEPTED

If you are accepted, you must withdraw any applications you submitted to other colleges. You are committed to enroll at Pace University if you are admitted through the Early Decision program. You are assured a place in the class, conditional upon your maintaining the same high level of academic achievement upon which your acceptance was based.

You must submit a nonrefundable deposit (\$600 for resident students and \$100 for commuter students) by February 15, 2024.

IF YOU ARE DEFERRED

If you are not accepted as an Early Decision applicant, your application may be deferred to the regular decision group for further consideration. If you are deferred, it is standard that our admission team requests mid-year senior grades as well as updated standardized test scores (if available) in order to provide a final decision. If you are not admitted through the Early Decision program but are admitted later on, your binding commitment is dismissed and you are no longer committed to enroll at Pace University.

HOW TO APPLY:

THE DEADLINE TO APPLY FOR EARLY DECISION AT PACE UNIVERSITY IS NOVEMBER 1.

A notification of your admission decision will be mailed by November 21.

TO BE CONSIDERED FOR EARLY DECISION, YOU MUST SUBMIT:

- A completed application
- Two letters of recommendation from a teacher and/or college counselor
- A written essay/personal statement of 250–650 words in length
- Official high school transcripts
- Official SAT or ACT scores (optional)
- The Early Decision Agreement form (attached) with the signatures of your parent or legal guardian and your college counselor
- \$50 application fee
