

• First Criminal Law class




What are our expectations of you?

Each academic credit = 55 minutes of classroom instruction + 2 hours of out-of-class work per week.

- 15 credit semester ≈ 45 hours per week

What is critical reading?

[It does NOT mean criticizing what you read]

- Reading for interpretation and understanding
- SQ3R: Survey, Question, Read, Recall, Review
- Engaging with the reading by asking yourself questions such as:
 - How does this text fit in to the bigger picture?
 - What is the legal rule this court is applying?
