The online Advanced Certificate in Health Law and Policy from the Elisabeth Haub School of Law at Pace University prepares students with or without a prior legal background to go for leadership roles in navigating the complexities of a changing healthcare system.

This program, which can be completed in one year, explores the regulations governing the US healthcare system at the federal and state levels, builds specialized lawyering skills, considers how policy

Curriculum

The certificate curriculum consists of 15 credit hours, including four core courses and your choice of one to two elective courses from a selection of 14. The available electives include options for pursuing research or an externship in your area of interest.

Online classes from Haub Law feature a combination of asynchronous activities you can complete on your own time and live sessions with faculty and peers. You will gain hands-on experience in solving the legal problems that face organizations in this industry.

You may take the core courses in any order. Two will be offered per semester and all four each year.

Admission and Tuition

Pace University holistically reviews all applications to the Advanced Certificate in Health Law and Policy to ensure students are prepared to succeed in a program focused on complex legal issues. Applicants are **not** required to hold a degree in law or have prior legal experience.

There are two opportunities to start per year, in the fall and spring, and we review applications on a rolling basis. You can expect to receive an admission decision within two weeks following receipt of your application and supporting documents.

Bachelor's degree in any field

Minimum GPA of 3.0 for most recent degree

Personal statement – Your two-page personal statement should explain your reasons for pursuing the Advanced Health Law and Policy certificate and how this credential will further your career aspirations.

TOEFL, IELTS or Duolingo scores (for international applicants) – If your native language is not English, you must submit evidence of English language proficiency. The Graduate Admissions Committee strongly prefers TOEFL scores of at least 90, IELTS scores of at least 6.5, or Duolingo scores of at least 120.

The law school may allow for conditional admission whereby the student takes an English program offered by Pace's English Language Institute and receives a passing grade.
