### **Pace University MS Program Objectives (PO) Annual Assessment Report 2024-2025**

The following is Pace University's Master of Science Program Objectives (POs) Assessment Report for the program's annual review. This plan includes input from the various stakeholders including: aggregate student assessment data that addresses student knowledge, skills, and professional dispositions; demographic and other characteristics of applicants, students, and graduates; and data from systematic follow-up studies of graduates, site supervisors, and employers of program graduates.

The assessment data compiled and analyzed is based on a five-point scale which is constituted as: 1 - Ineffective, 2 - Somewhat Effective, 3 – Adequate, 4 – Effective, 5 – Very Effective.

We are continuing to use the standard baseline minimum of 80% for this academic year. Additionally, we have included Adequate, Effective, and Very Effective in the five-point scale to calculate our aggregate outcome.

**86% of our stakeholders indicated that the program was Effective or Very Effective in meeting the program objectives. 99% of our stakeholders indicated that the program was Adequate, Effective or Very Effective in meeting the program objectives. These averages are year on year consistent with data from AY 2023-2024, confirming consistency in meeting program objectives.**

### Narrative Summary of Annual Program Assessment Findings

Stakeholder feedback for AY 2024–2025 indicates strong and consistent satisfaction with the Mental Health Counseling program’s effectiveness in meeting its objectives. Overall, **86% of stakeholders rated the program as Effective or Very Effective**, and **99% rated it as Adequate, Effective, or Very Effective**. These outcomes align closely with AY 2023–2024 data, demonstrating year-over-year consistency in the program’s ability to meet its stated objectives.

As outlined in the Program Outcomes (PO) Assessment Plan, the program examines multiple data sources to evaluate effectiveness, including student performance, alumni and employer feedback, site supervisor evaluations, and professional disposition assessments.

#### 1. Demographic and Student Outcome Data

For AY 2024–2025, the program enrolled **137 students** and conferred **39 degrees**. Completion rates remained high at **98%**, and **100% of students secured field placements**. Among graduates, **73% reported employment in the field** based on survey data. The pass rate for the NYS NCMHCE credentialing exam was **60%**, indicating an area for continued monitoring and support.

#### 2. Program Learning Outcomes Assessment

Assessment across the nine Program Learning Outcomes (PLOs) demonstrates consistently high levels of student achievement and stakeholder confidence. Aggregate data from coursework,

surveys, and supervisor and employer evaluations show that all nine PLOs were met with strong performance indicators, ranging from **94% to 100%**, with **no action plans required** for most areas.

Across all PLOs—including Professional Counseling Orientation and Ethical Practice; Social and Cultural Diversity; Human Growth and Development; Career Development; Counseling and Helping Relationships; Group Counseling; Assessment and Testing; Research and Program Evaluation; and Clinical Mental Health Counseling—stakeholder evaluations consistently reflected exceptional competency development among students and graduates. Notably:

- Assessments related to **social and cultural diversity** maintained gains achieved in the prior academic year, with continued monitoring to ensure that students have ample opportunities to enhance multicultural competence.
- Site Supervisor Survey results for **Assessment and Testing** demonstrated improvement from the previous year (91% to 95%), reflecting increased confidence in students' assessment skills.

### **3. Annual Program Aggregate Professional Disposition Data**

The program systematically assesses professional dispositions as a core component of counselor preparation. Dispositions are evaluated across the following domains: humility, respect, openness, commitment, integrity, and self-awareness, aligning with expectations for ethical practice, professional responsibility, and reflective clinical work.

The minimum threshold for acceptable aggregate program performance on professional dispositions is that at least 80% of students earn an overall score of 13-1, indicating “Meets Expectations,” within each academic year. For AY 2024–2025, the program’s aggregate disposition score was 18.89, exceeding the established benchmark and demonstrating that students, as a whole, consistently met or surpassed professional disposition expectations.

### **Conclusion**

AY 2024–2025 assessment results affirm the program’s continued effectiveness in preparing students for professional practice in mental health counseling. The data reflect sustained excellence across coursework, field experiences, and post-graduation outcomes, with stakeholder feedback confirming strong alignment between program objectives and graduate competencies. While the program will continue to monitor licensure exam performance and support multicultural competency development, overall findings indicate that the program is meeting its goals with a high degree of consistency and effectiveness.

### **3. Other Substantial Program Changes**

#### **Hardware Update:**

During the AY 2024–2025, the MS in Mental Health Counseling received Dyson approval for 50 new laptop devices. Prior to procurement of the devices, the IT Department devised enhanced security protocols and procedures for the devices to ensure HIPAA compliance, enhanced security through modified air-gapping and faculty specific access.

#### **Personnel Changes:**

The MS in Mental Health Counseling hired Dr. Lisa Bonaviso during AY 2024–2025.

**Curriculum Changes:**

During AY 2024–2025, the MS in Mental Health Counseling submitted the reaccreditation self-study. As such, no significant curriculum changes were made.
