



## THE PACE UNIVERSITY CONDUCT POINTS SYSTEM

### HOW IT WORKS

- ◇ A student found responsible for violating University, and/or Guide to Residential Living-policy is assigned points according to the table of violations
- ◇ Points and/or other sanctions are assigned after the Resolution Meeting Process
- ◇ Points remain active for 1 calendar year after a student receives them
- ◇ Previous violations are considered before points and/or other sanctions are assigned
- ◇ If a student reaches 15 conduct points, they may be removed from on-campus housing

### SANCTIONS

The following schedule of sanctions is intended to serve as a predictor for most policy violations and therefore is not inclusive of all possible sanctions. Other sanctions are outlined in the Guide to Residential Living but are not limited to, mandatory alcohol/drug referral to the Counseling Center, monetary fine, etc.

### POSSIBLE SANCTIONS

Written Warning | Educational Sanctions: Alcohol & Other Drugs Online Module, Community Service, Reflection Papers

Athletic Director/Coach Notification | Parent Notification | Probation

Alcohol & Other Drug Referral to the Counseling Center | Housing Relocation/Removal | Final Warning | Suspension | Expulsion

**AMNESTY POLICY:** *Situations in which the University's Amnesty Policy has been applied will have no points assigned, but all other sanctions may still apply*

***\*Students found responsible for intentional or reckless destruction of University or private property are assigned 4-10 points.Any student found in violation of the Vandalism Policy will be required to pay the cost of the repair/replacement, with a \$100 minimum charge, plus a \$100 vandalism fine.***
